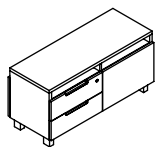
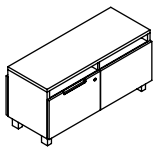

WHAT'S INCLUDED

Case and drawers, filing accessory (if box drawers are specified), hanging bar (when files drawer specified), false fronts, counterweights (if specified).

WHAT'S EXCLUDED

Mobile trays, cushion

NOTES

Backs include false front add-ons to match the front style and finish.

Counterweights are required in freestanding applications.

If Filing Accessory for box drawer is specified, the dividers match the color of the upStage handle, while the liner defaults to Ebony (Source Laminate) or Foundation Grey (Seamless, Flintwood, Veneer front).

The cubby space for trays are open through (no backs), are accessible from both sides.
